ARRIVAL – ALL CATTLE MUST BE IN THE BARN BY 4:00 P.M. ON FRIDAY, OCTOBER 29, 2021. LIVESTOCK WILL NOT BE RECEIVED PRIOR TO 12:00 P.M. ON FRIDAY OCTOBER 29, 2021.

RELEASE – ALL CATTLE MUST REMAIN IN BARN UNTIL AFTER THE COMPLETION OF THE SALE WITH THE EXCEPTION OF THE DAMS IN THE PEOPLE’S CHOICE COW/CALF PAIR CLASS. THEY WILL BE RELEASED RIGHT AFTER THE SHOW ON FRIDAY, OCTOBER 29, 2021.

SALES COMMISSION : 4% OF SALE PRICE.

SHOWING AND SALE OF ANIMALS :

THE FALL FAIR BOARD REQUIRES THAT ALL EXHIBITORS WHO HAVE ENTERED ANIMALS BE IN ATTENDANCE, OR HAVE A QUALIFIED REPRESENTATIVE, IN ORDER TO EXHIBIT AND SELL THEIR ENTRIES. THIS INCLUDES BRINGING THEM TO THE SHOW RING FOR THE CLASS AND SALE AS WELL AS REPLACING THEM TO THEIR PENS AFTER THE SHOW AND SALE.

PROSPECT CALF SHOW AND SALE

THESE CLASSES ARE OPEN TO ALL CALVES OF THE CURRENT YEAR. ALL CALVES MUST BE DEHORND AND CASTRATED. EXHIBITORS SHOULD HALTER BREAK CALVES, TO ALLOW SUFFICIENT CONTROL IN THE SHOW RING. ANIMALS MAY BE WASHED AND CLIPPED. ALL CALVES ARE TO BE WEIGHED AND HAVE WEIGHT POSTED. EXHIBITORS ARE ONLY ALLOWED TO ENTER TWO ANIMALS PER CLASS.

RANCHERS’ CHOICE STEER & OPEN REPLACEMENT HEIFER SHOW AND SALE

OPEN TO ALL CALVES OF THE CURRENT YEAR. ALL CALVES MUST BE CASTRATED AND DEHORND. CALVES MAY BE HALTER BROKE, BUT THEY WILL BE SHOWN WITHOUT HALTER. CALVES MAY BE WASHED, BUT THEY CAN NOT BE CLIPPED OR BURNED.

ALL OTHER QUALIFICATIONS ARE THE SAME AS THE PROSPECT SHOW.

PEN OF THREE AND PEN OF FIVE OPEN HEIFERS SHOW AND SALE

ENTRIES IN THESE CLASSES MAY BE WASHED AND BRUSHED IF DESIRED. NO CLIPPING OR BURNING OF HAIR OR ANY OTHER FORM OF SHOW PREPARATION WILL BE ALLOWED. ANY EVIDENCE OF THE ABOVE PRACTICES MAY CAUSE ENTRY TO BE DISQUALIFIED.

ANIMALS NEED NOT BE HALTER BROKE. THEY WILL BE STALLED AND SHOWN IN PENS.

A CONTRIBUTOR MAY ONLY ENTER IN THE OPEN CLASSES’ TWO GROUPS OF THREE, OR TWO GROUPS OF FIVE, OR ONE GROUP OF THREE AND ONE GROUP OF FIVE. CONTRIBUTORS OF OPEN FEMALES MUST GUARANTEE THEM **NOT TO BE PREGNANT.**

PEN OF THREE AND PEN OF FIVE BRED HEIFERS SHOW AND SALE

ENTRIES IN THESE CLASSES MAY BE WASHED AND BRUSHED IF DESIRED. NO CLIPPING OR BURNING OF HAIR OR ANY OTHER FORM OF SHOW PREPARATION WILL BE ALLOWED. ANY EVIDENCE OF THE ABOVE PRACTICES MAY CAUSE ENTRY TO BE DISQUALIFIED.

ANIMALS NEED NOT BE HALTER BROKE. THEY WILL BE STALLED AND SHOWN IN PENS.

A CONTRIBUTOR MAY ONLY ENTER IN THE BRED CLASSES’ TWO GROUPS OF THREE, OR TWO GROUPS OF FIVE, OR ONE GROUP OF THREE AND ONE GROUP OF FIVE.

BRED HEIFERS MUST BE PREGNANCY TESTED WITHIN 30 DAYS OF THE FALL FAIR. A VETERINARY CERTIFICATE MUST ACCOMPANY THE CATTLE TO THE SHOW.

PLEASE NOTE THAT DUE TO FEED SHORTAGES THIS YEAR, HAY BALES WILL NOT BE PROVIDED AND WE ASK THAT CONTRIBUTORS BRING THEIR OWN FEED TO THE SHOW.

PEOPLE'S CHOICE COW / CALF PAIR

ALL COWS ENTERED IN THIS CLASS MUST HAVE HER NATURAL HEIFER CALF BORN AFTER JANUARY 1, 2021 AT SIDE. LIMIT OF ONE ENTRY PER FARM UNIT.

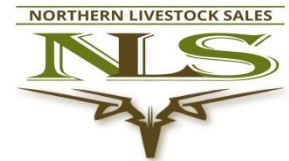
ALL ENTRIES IN THE CLASS WILL HAVE THEIR HEIFER CALVES SOLD ON SATURDAY IN THE SALE. ALL COWS MUST BE LOADED OUT FRIDAY NIGHT WITH THE POSSIBLE EXCEPTION OF THE GRAND AND RESERVE CHAMPION DEPENDING ON ROOM.

ENTRIES IN THIS CLASS MAY BE WASHED AND BRUSHED IF DESIRED. NO CLIPPING OR BURNING OF HAIR OR ANY OTHER FORM OF SHOW PREPARATION WILL BE ALLOWED. ANY EVIDENCE OF THE ABOVE PRACTICES MAY CAUSE ENTRY TO BE DISQUALIFIED.

VOTING BALLOTS WILL BE SOLD AT \$20.00 EACH. EACH PERSON HOLDING A BALLOT WILL JUDGE THE COW/CALF PAIRS BETWEEN 6:00 P.M. AND 9:00 P.M. ON FRIDAY EVENING. AT THE COMPLETION OF JUDGING THE PEOPLE'S CHOICE COW/CALF PAIR WILL BE CALCULATED AND ANNOUNCED.

EVERY PERSON WHO PURCHASES A BALLOT AND JUDGES THE PAIRS WILL HAVE THEIR NAME ENTERED INTO A DRAW. ONE NAME WILL BE DRAWN AND THAT PERSON WILL HAVE THE OPPORTUNITY TO PICK A HEIFER CALF FROM ANY OF THE PAIRS. THIS PERSON IMMEDIATELY TAKES 100% OWNERSHIP OF THAT HEIFER CALF AND THEY CAN EITHER TAKE THE HEIFER HOME OR THEY CAN CHOOSE TO SELL HER IN THE SALE SATURDAY. THE CONTRIBUTOR WHO HAS THEIR HEIFER CALF SELECTED WILL RECEIVE **\$2000**. IF THE PERSON DRAWN, OR THEIR FARM, HAS A PAIR ENTERED IN THE SHOW THEY MAY **Not** SELECT THEIR OWN ANIMAL.

PEN OF THREE PUREBRED BULLS

ENTRIES IN THE BULL CLASS MUST BE BORN IN THE CALENDAR YEAR OF THE SHOW AND ALL BULLS MUST BE PUREBRED. WEIGHT PER DAY OF AGE MUST BE DISPLAYED. **THIS CLASS WILL BE DIVIDED INTO A BRITISH / EXOTIC SPLIT WITH A GRAND & RESERVE GRAND CHAMPION NAMED IN EACH SPLIT.**

ENTRIES IN THE BULL CLASS MAY BE HALTER BROKEN AND TIED AT THE DISCRETION OF THE CONTRIBUTOR. THEY WILL HOWEVER BE SHOWN IN PENS.

THE EDAM FALL FAIR COMMITTEE REQUESTS THAT ALL BULL CONTRIBUTORS PLEASE REMEMBER THAT THIS IS A COMMERCIAL CATTLE SHOW AND AS SUCH, NO FORMS OF SHOW RING PREPARATION ARE PERMITTED. BULLS MAY BE WASHED, BLOWN, BRUSHED, AND COMBED BUT NO CLIPPING OR BURNING OF HAIR OR THE USE OF ANY PRODUCT THAT ALTERS OR ENHANCES THE NATURAL GLOSS, CONDITION, OR COLOUR OF THE HAIR IS PROHIBITED. THIS INCLUDES THE USE OF CONDITIONERS, OILS, SHOW SHEENS, BASE COATS, HAIR SETS, ADHESIVES, ALCOHOLS, OR COLOURING AGENTS. THIS RULE WILL BE STRICTLY ENFORCED AND ANY CONTRIBUTOR FOUND IN VIOLATION WILL BE ASKED TO LEAVE THE RING PRIOR TO JUDGING. THE EDAM FALL FAIR COMMITTEE BELIEVES IN THE INTEGRITY OF THE PUREBRED INDUSTRY AND IS CONFIDENT THAT THE **"NO DRESS"** RULE WILL BE ADHERED TO BOTH IN ITS LETTER AND INTENT.

AGAIN THIS YEAR - ALL CONTRIBUTORS WILL BE ENTERED INTO THE PEOPLE'S CHOICE PEN OF BULLS. THIS WILL RUN FROM FRIDAY AT 6:00 P.M. TILL THE START OF THE BULL SHOW SATURDAY. ANYBODY CAN PURCHASE A BALLOT FOR \$5.00 AND BE ELIGIBLE TO JUDGE THE BULLS. THE WINNING PEN WILL RECEIVE A JACKET AND THE HONOR OF BEING NAMED PEOPLE'S CHOICE PEN OF BULLS. ALL BALLOT HOLDERS WILL BE ENTERED IN A DRAW FOR A PRIZE DONATED BY **SASKATCHEWAN CHAROLAIS ASSOCIATION**.

GENERAL RULES AND REGULATIONS

Exhibitors are requested to familiarize themselves with the rules and regulations governing the Fall Fair, as they are strictly enforced.

Violation of Rules

All entries for exhibits, shows, sales, and displays in the annual show sponsored by the Edam Fall Fair are subject to the rules and regulations and any violations will subject exhibitors to such penalties the management may stipulate.

Interpretation

The board of directors has the final and absolute right to interpret the rules and regulations and to determine all matters, questions, and differences in regard thereto, and otherwise arising out of or in connection with or incidental to the Fall Fair. The board of directors has the right to amend or add to these rules and regulations.

Liability

The board and committee members, while taking every precaution, can not hold themselves responsible for damage to or loss of exhibits.

Every exhibitor shall be deemed to be in full charge of and responsible for any loss to such exhibits, or for injuries or damage thereto from the time that such exhibits commence to be transported to the premises of the Fall Fair and until such exhibit is delivered thereon shall be deemed to be at the risk of the exhibitor, except in the case of an exhibit being sold, when the same shall remain on such premises at the risk of the purchaser at such sale, and in either the Fair committee shall not be liable for the loss of any such exhibit or for any injury or damage thereto, notwithstanding such loss, injury, or damage arising through or by negligence of the Fair committee or any of its officers, servants, or agents.

If any damage, loss, or injury to person or property shall be caused by neglect or willful act of any person, firm or corporation, or their agents, representatives, servants, or employees sharing license or privilege to exhibit on said Fair ground, occupying any space thereof, and in case it be subjected to any expense or liability all persons causing same or liable therefore shall indemnify the said Fall Fair Committee.

Entry Fees

All entries, accompanied by fees, must be made payable to **EDAM FALL FAIR**. All entry fees will be allocated to Prize Money – GST not applicable.

Entry Forms

All entries must be made on the printed entry forms supplied for this purpose. The particulars called for on the entry form **MUST BE FULLY** supplied in clear, legible writing, printed or typed, properly signed by the exhibitor or his/her duly authorized agent. Forms may be obtained by writing Edam Fall Fair, Box 410, Edam SK, SOM OVO.

Refusing Entries

The Fall Fair Committee reserves the right to refuse any entry.

Refunds

No refunds of entry fees will be made after the cattle have been catalogued. Exhibitors making entries and not exhibiting them shall forfeit all fees paid for entries.

Erroneous Entry

Animals that have been erroneously entered may be transferred to the proper section prior to the judging, upon application to the General Manager. If such sections have been judged, they shall not be reopened.

Arrival and Release of Exhibitors

If you decide to exhibit at this show, you are expected to keep your livestock on the grounds until the sale is over. **Livestock will not be received into the barns prior to Friday, October 29, 2021 at 12:00 p.m. All livestock must be in the barns prior to 4:00 p.m. Friday, October 29, 2021.**

EXHIBITORS VIOLATING THE RELEASE TIME WILL BE SUBJECT TO A PENALTY AS DEEMED NECESSARY BY THE EDAM FALL FAIR BOARD OF DIRECTORS. THE PENALTY COULD INVOLVE THE LOSS OF PRIZE MONEY AND DISBARMENT FROM FUTURE SHOWS.

Show Catalogue

Show catalogues will not be mailed to exhibitors in advance of the show. All catalogues will be available on the show premises.

Weighing

Weighing is mandatory and weights are to be displayed.

Reminder : All livestock attending show need to be CCIA tagged.

Diseased Animals

All animals on the grounds will be subject to veterinary inspection if necessary. No animals having contagious diseases shall be allowed to occupy any stall or building, or be admitted to the Fair grounds, and if any animal has been admitted through an oversight, suffering from any such disease, the Manager shall immediately order its removal from the grounds.

Stalls & Stabling

The Fair committee will supply, free of charge, stable room and water for all animals properly entered. Feed troughs are not supplied. The Fall Fair will supply first bedding for entries. Exhibitors will be stabled under the supervision of the Barn Boss.

Wash Rack Use

Only prospect cattle will be allowed to use the wash rack.

Platforms

Platforms or other build up materials for use in stabling cattle will not be permitted.

Manure

Manure must be placed in the proper areas.

Dress of Attendants

Those showing cattle in the ring must wear clean and tidy clothing. No farm or herd advertising on exhibitors while showing in the show ring.

Leaving the Ring

Animals winning prizes must not leave the ring until the prize has been awarded to them.

Payment of Funds

By November 15th or sooner if all funds are cleared. All persons to whom prizes have been awarded and who do not receive prizes as above, must apply to the general manager in writing for payment thereof, not later than December 15, 2021 or such prizes will be forfeited.

Decision of Judges

A judge shall have uncontrolled power to decide all questions as to the winner of any event over which such judge presides and the awarding of the prize and the decision of such judge on any such question shall be final and there shall be no recourse therefrom.

When there is only one exhibitor in any such event or where the judge is of the opinion that all the animals exhibited do not justify an award, such judge may withhold the awarding on any award of the same, or any award prizes according to the standard merited by reason of quality, rather than numbers of exhibits.

Time of Showing

The livestock judging program will be published and announced and exhibitors are required to act accordingly. Any animals not presented in the ring at the time scheduled will be barred from showing.

Show Ring Rules

No person will be permitted in the cattle ring during the time of judging except the judges, the exhibitor, the assistant in charge of the animals, committee members, and members of the press.

Breeding Capabilities

In cases where doubt exists in the mind of the judge or officials as to breeding capability of an animal, the exhibitor thereof may be required to furnish evidence to the satisfaction of the officials concerned.

Barn Superintendent

The barn superintendent has complete authority over the stabling of livestock in the barns, allocation of tie out spaces and control of trimming chutes and trimming in the barns. The duties of the cleanliness of the barn and aisles and provisions of assistance to the exhibitors with problems in the barns are also his duties.

Supervisor (Barn Boss) Duties Include:

- 1) Assist exhibitor with stabling on arrival.
- 2) Assist with the weighing of livestock.
- 3) Co-operate in keeping stall areas and aisles clean and tidy at all times.
- 4) Assist the exhibitors with problems in their respective barns.
- 5) Attend the Barn Boss meeting each morning with management to provide information to help run a smooth show.
- 6) Maintain proper conduct and encourage co-operation among exhibitors.

Covid-19 Protocols

Due to the constant changing situation and environment with regards to the COVID-19 Pandemic, we want all contributors and visitors of the Edam Fall Fair to know that we will be following all of the current Public Health Orders and Recommendations of the Saskatchewan Government and Sask Health Authority during this event.

Please try to keep yourself up to date with regards to masking and any other restrictions that will need to be followed during the show and sale.

We also want contributors to know that, due to feed shortages in the area this year, the Edam Fall Fair will be unable to provide hay bales as feed and ask that all contributors provide their own source of feed at this year's show.
